1 **LDD Federal Government-Drug Free Schools**

3 The possession, use, sale or distribution of illicit drugs and alcohol or facsimiles thereof
4 by students or school employees on or in district property or as a part of any district activity is
5 prohibited. The use or possession of any substance that has a mind-altering effect is prohibited,
6 excluding a prescription-only medication prescribed by a physician or over-the-counter
7 medications which are being taken according to label direction for a legitimate ailment. This
8 policy, and any curriculum used in conjunction with it, shall be evaluated and updated
9 periodically using criteria developed by the superintendent and approved by the board. (See
10 GAOA, GAOB, IDAB, and JDDA)
